The Criminal Justice Coordinating Council (CJCC), a body of justice system leaders that works to coordinate systemic responses to improve the local criminal justice system, is seeking a group of diverse community representatives to join its team. The CJCC's mission is to assist in making sustainable, data-driven improvements to Charleston County's criminal justice system and thereby improve public safety and community well-being.

The CJCC will consider the input and voices of the community representatives in its decision- making process. One member will be elected by the other members of this group and will have full voting rights. The CJCC is looking for representation from seven areas for the 2019 – 2021 term to join those currently serving the 2018-2020 term.

Community representatives are respectfully requested to attend CJCC meetings and actively participate in community engagement efforts. Representatives may not serve more than two consecutive terms.
