Feedback: Lunch Discussion Group Themes

Criminal Justice Coordinating Councils

- Why: Several CJCCs starting up in need of more information, expertise, support and partnerships (local and state level)
- What: Applied system data analysis, governance and help with interventions for specific issues (pretrial matters, recidivism, SUD/MH, community engagement, etc.)
- How: Gathering in-person, online, email, web platform for sharing resources

Disparities

- Why: Desire to know more about discriminatory practices and various community resources available
- What: Do more to support reentry (e.g., mental health treatment, medication supply, tracking system from SCDC to service providers, community health workers)
- How: Increase stakeholder collaborations and resources available

Deflection and Diversion

- Why: Treatment over incarceration, can't arrest our way out of the problem, even the first few interactions can have devastating consequences, lack opportunities and need for appropriate resources, programs work, reduce calls for service
- What: data collection/need to assess effectiveness, learn more about the existence of diversionary programs and ways to access them without 911
- How: Identify gap in resources/transitionary periods, wrap around services after immediate crisis/need, change policy for reimbursement, conduct cost-benefit analysis

Feedback: Lunch Discussion Group Themes

Research and Data

- Why: Objectivity, accountability and transparency, process improvement, inform decisions and funding, doing what you say
- What: Studies on various subjects (i.e., community engagement, recruitment and retention, detention centers, calls for service, recidivism, etc.)
- How: Data discussions with community, partnerships, data access, detention center data, police expectations, mental health response, unifying reporting systems, staffing

Reducing Violence

- Why: High and sustained rates of community violence, especially involving youth
- What: Mental health interventions, specific programs founded on cognitive behavioral therapy, need tools that are most likely to be successful
- How: Programs to reduce youth-involved violence and support reentry

Pretrial Justice

- Why: Desire to better understand the issues, data, research and areas for improvement
- What: Clarify terminology, assess existing practices, find solutions
- How: Keep working at it, do better

Feedback: Additional Survey Themes (Open Text)

- Suggestions for future network activities offered by 50% of respondents
 - Spend more time on key subjects (such as mentally ill in detention centers, conditions in facilities, lived experiences, first responder trauma, community helpers)
 - More breaks, more time to dig into topics and problem solve, more breakout sessions, more interaction with one another
 - Make asks of participants such as legislation to advocate for/against
- Additional feedback offered by 61% of respondents
 - Important to be mindful of trauma, suggested statement to share with speakers and audience:
 - "Given the sensitive nature of the material, information, cases, and experiences we are sharing, let us continue to be mindful that we are not only sharing facts and statistics, but real people's lives, even traumas. There is a face to every story."
 - "Very engaging and rewarding experience. Networking with other entities in the criminal justice system as well as the community partner was an excellent experience."
 - "I love the work that this team is doing. Everyone is so dedicated!"
 - "The exchanges among statewide participants can be a great multiplier of data driven local studies."

Lessons Learned

- The Inaugural Conference was a success
 - Great interest, turnout, content, and feedback
 - Participation varied by stakeholder group and geography
 - · Conference app had strengths and challenges
- Leadership is critical
 - It's a lot of work! Co-Chairs and CJCC staff were essential to making it happen
 - Steering Committee members were very helpful; however, in the short timeframe meeting attendance and contributions varied
 - Speaker coordination, support and guidance matters
- Going Forward
 - There is a great need and demand for continued network efforts
 - Clear direction, infrastructure and support required

Form an updated 2024 Steering Committee
